

# **Notice Seeking Nominations**

## ***DETCOG Minority Board Member***

**Nominations are now being accepted for the San Jacinto County Minority Representative to serve on the Board of Directors of the Deep East Texas Council of Governments (DETCOG).**

### **Qualifications to Serve:**

- Must be a member of a racial or ethnic minority group
- Must be age 18 or older and a resident of San Jacinto County for at least six consecutive months
- Must be willing and able to attend monthly out-of-town meetings

*This is a volunteer position with no pay and no expenses paid. Meetings are held in a different county in the DETCOG region each month, usually on the 4<sup>th</sup> Thursday of the month at Noon. You will be responsible for your transportation and meals.*

### **How to Place Your Name in Nomination:**

- Submit an official Nomination Form to the DETCOG Executive Director no later than **March 20, 2017**. The Nomination Form is available from the San Jacinto County Judge's Office or from the DETCOG Office at 210 Premier Drive in Jasper, Texas. It may also be downloaded from the DETCOG website at [www.detcog.org](http://www.detcog.org).
- Obtain the signatures of at least ten (10) other San Jacinto County residents age 18 or older who are members of a racial or ethnic minority group.
- Instructions are included on the Nomination Form. Late nominations will NOT be accepted.

### **Election Process:**

If more than one qualified person successfully completes the nomination process, an election will be scheduled and announced. Residents of San Jacinto County age 18 or older who are members of a racial or ethnic minority group may participate in the election.

*Racial Minority Groups:* Groups who are classified according to obvious physical characteristics such as skin color. Some examples include African Americans, American Indians and Asian Americans.  
*Ethnic Minority Groups:* Groups who are differentiated on the basis of culture such as language or food. Some examples include Hispanics or Latinos.
3. I understand the commitment I am making and I am willing and able to make it. I will be expected to attend monthly out-of-town meetings at my own expense. Meetings are held in a different DETCOG county each month, usually on the 4<sup>th</sup> Thursday at noon. DETCOG counties are: Angelina, Houston, Jasper, Nacogdoches, Newton, Polk, Sabine, San Augustine, San Jacinto, Shelby, Trinity and Tyler.
4. I understand this is a volunteer position with no pay and no expenses paid.
